# K. Complaints Handled:

- *Otero vs.* US Career Institute 12/10/2015 Tuition of \$639.96 refunded to student. Complaint closed.
- *Pope vs. Brensten Education* 12/17/2015 Brensten provided documentation that it had acted properly in EAYL payments, did not collect tuition money while student was on leave, and submitted an Enrollment agreement with student's signature for the total program cost. Complaint closed.
- *Young vs. Brensten Education* 12/17/2015 Student was dismissed for lack of attendance; and Brensten collected federal financial aid only for periods in which student attended Brensten.
- Mendez vs. Wisconsin School of Professional Pet Grooming, Inc. 1/7/2016 After an
  investigation and school visit, the EAB did not find the school in violation of any EAB rules.
  Complaint closed.
- *Mabins vs. Brensten Education* 1/5/2016 Brensten has legal obligations not to enroll students who have tuition funding shortfall, which student had. Complaint closed.
- *Heath vs. Art Institute of Wisconsin* 1/6/2016 The EAB did not find any violations. The EAB's findings of 12/3/2015 remain unchanged. Complaint closed.
- *Gastaldi vs. Capella University* 1/29/2016 The school was found not have violated any EAB statutes or rules. No refund due to student. Complaint closed.
- *Holat vs. Wisconsin School of Professional Pet Grooming* 2/12/2016 The school was found to not have any violations and met EAB Standards. Complaint closed.
- *Babbitts vs. Rasmussen College* 3/4/2016 Rasmussen addressed concerns raised by student and awarded an institutional grant of \$5,580 to assist with the completion of her program.
