SCHOOL ACTIONS

A. *New School Approval:*

- *Green Lotus Yoga & Healing Center, Lakeville, MN*
The Center integrates 200-hour and 300-hour yoga teacher training so that students have ultimate flexibility to create a program that accommodates their time, demands, and budgets. Built on a disciplined foundation of yoga philosophy and history, teaching principles, anatomy, breath work, meditation, and poses in the 200-hour program, students complete this training skilled in delivering yoga safely and confidently in their authentic voices. They are supported by dedicated faculty who know their students well because of the limited class sizes. The school's advanced 300-hour program is delivered in independent modules that can be taken as continuing-education courses or aggregated to complete what is considered in yoga education to be a graduate level that awards the 500-hour designation to teachers who successfully complete the coursework.
- *Hazelden Betty Ford Graduate School of Addiction Studies, Center City, MN*
The Hazelden Betty Ford Graduate School of Addiction Studies is an institution of higher education within the Hazelden Betty Ford Foundation. The Foundation is a not-for-profit multi-resource center for addiction based on core competencies in treatment, education, research, and publishing. Since its early beginnings in 1949, Hazelden Betty Ford has educated students, patients, family members, interns, professionals, and the public regarding the prevalence, prevention, assessment, and treatment of alcohol and drug dependency. The Graduate School was established as an outgrowth of the Foundation's commitment to education, admitting its first class in 1999.
- *Tosa Yoga Center Teacher Training, Wauwatosa, WI*
The Center's Teacher Training program will be located within Tosa Yoga, LLC. The Instructors are experienced, registered yoga teachers with the Yoga Alliance. Students will attend classes one weekend per month for 10 months. They will complete 223 hours, exceeding the Yoga Alliance requirements. The program will be open to students who wish to become teachers or to deepen their own practice and journey.
- *Utica College (Online), Utica, NY*
The College is a coeducational, private, comprehensive college founded by Syracuse University in 1946. It became accredited in 1995 and began offering graduate programs that grant the UC master's degree in 1999 and the UC doctoral degree in 2005. Utica College offers 37 majors, 27 minors, 21 graduate programs (including master's, doctoral and graduate certificate programs) online and on-campus.
- *Yoga on the Lake, Kohler, WI*
Yoga on the Lake's (YOTL) 200-hour teacher training program (RYT-200) offers a unique experience and education for yoga students. In the YOTL's program, students will receive hands-on experience and constructive feedback from the school's team of Experienced Registered Yoga Teachers (E-RYT). YOTL's teacher training program will enable students to teach an intelligent, safe, and grounded Vinyasa yoga class that is accessible to all levels of

practitioners. Students will receive practical teaching experience, anatomy education, yoga philosophy, and ethics.

- *Feeny vs. Upper Iowa University, 8/15/2016* – The school contacted and offered the student to retake the classes with tuition waived. Student enrolled in classes from 6/27/16 to 8/21/16. Complaint closed.
- *Fuller vs. Upper Iowa University, 8/15/2016* – The school contacted and responded to complaint refunding \$6,171 cost of tuition. Complaint closed.
