The School was created with the intent to provide a safe and welcoming environment allowing students to explore and deepen their practice of yoga. The school's mission is to remain true to the roots and philosophies of yoga and to serve the community by offering students a space to cultivate peace, compassion, wisdom, and acceptance.
- *Oak Tree Massage School, Rice Lake, WI*
The School is a private, postsecondary, non-degree school in Rice Lake, Wisconsin. It provides a 700-hour Massage Therapist Program. Supplies and equipment, student insurance, testing fees, test prep supplies, license fees and basic massage table starter kit are all included. This ensures that the students not only graduate with an excellent education, and all the equipment needed to start work, but also complete the state and national tests and apply for Wisconsin licensure.
